NUMBER 47 OF 2009
CONCERNING
TYPE AND RATE OF TYPE OF NON TAXATION STATE REVENUE
PREVAILING IN THE MINISTRY OF RESEARCH AND TECHNOLOGY**

WITH THE BLESSING OF THE ONLY GOD

PRESIDENT REPUBLIC INDONESIA,

Considering : whereas for implementing the provision of Article 2 paragraph (2) and paragraph (3) as well as article 3 paragraph (2) Laws Number 20 of 1997 concerning Non Taxation state revenue, needs to stipulate a Government Regulation concerning Type of Non Taxation State Revenue prevailing in the State Ministry of Research and Technology.

In View of : 1. Article 5 paragraph (2) Constitution of Republic of Indonesia of 1945;
2. Laws Number 20 of 1997 concerning State Revenue (State Gazette of Republic of Indonesia of 1997 Number 43, Addendum of State Gazette of Republic of Indonesia Number 3687);
3. Government Regulation Number 22 of 1997 concerning Type and Depositing Non Tax State Revenue (State Gazette of Republic of Indonesia of 1997 Number 57, Addendum of State Gazette of Republic of Indonesia Number 3694) as it has been amended Number 52 of 1998 (State Gazette of Republic of Indonesia of 1998 Number 85, Addendum of State Gazette of Republic of Indonesia Number 3760);

HAS DECIDED:

To Stipulate : **GOVERNMENT REGULATION CONCERNING TYPE OF NON TAX STATE REVENUE PREVAILING IN THE STATE MINISTRY OF RESEARCH AND TECHNOLOGY.**

Article 1

- (1) Type of Non Tax State Revenue prevailing in the State Ministry of Research and Technology consists of revenue from:
 - a. permission of research and development for:
 1. Foreign University
 2. Foreign Research and Development Institution
 3. Foreign Business Entity
 4. Foreigner
 - b. selling of research and development result of Joint Agro Technology Center; and
 - c. service of lease of facilities in Center for Research, Science and Technology (PUSPIPTEK).
- (2) Type and rate of the type of Non Tax State Revenue as mentioned in paragraph (1) is as stipulated in the Appendix of the Government Regulation herein.

Article 2

Type of Non Tax State Revenue as mentioned in Article 1 paragraph (1) has rates in rupiah and dollar currencies.

Article 3

- (1) In relation to the type of Non Tax State Revenue derived from the Permit of research and development for Foreign University and Foreign Research and Development Institution as mentioned in article 1 paragraph (1) letter

a number 2 who carries out any research under the intergovernmental cooperation shall be the rate as amount to USD 0,00 (zero American Dollar).

- (2) Imposition of the rates upon the type of Non Tax State Revenue derived from facilities in Center for Research, Science and Technology for Micro, Small and Medium Businesses, Formal Education Institution, Ministry of Research and Technology and Non Department Government Institution coordinated by State Ministry of Research and Technology, and the Researcher must fulfill certain requirements and procedures.
- (3) The further provisions concerning the criteria, requirements and procedure of rates imposition as mentioned on paragraph (1) and paragraph (2) shall be regulated by the Regulation State Minister of Research and Technology following to obtain the consent from the Financial Minister.

Article 4

The entire Non Tax State Revenue prevailing in the State Ministry of Research and Technology must be directly as soon as deposited to the State Treasury.

Article 5

By the time of the Government Regulation herein is in effect, the provision of Article 1 paragraph (1) letter b and appendix number II of Government Regulation Number 75 of 2007 concerning the Type of Non Taxation State Revenue prevailing in the Indonesian Science Institution (State Gazette of Republic of Indonesia of 2007 Number 159, Addendum of State Gazette of Republic of Indonesia Number 4361), shall be abrogated and stated as ineffective.

Article 6

The Government Regulation herein shall be effective since the date of the enactment.
